### **Request for Temporary Road Closure**

**THE TOWN POLICE CLAUSES ACT 1847**

**TEMPORARY PROHIBITION OF TRAFFIC**

**WHEREAS** the Stroud District Council is satisfied that traffic on the streets set out in the Schedule hereto should be prohibited between the hours and dates set out on the schedule below for the purposes of holding **Cam's Christmas lights switch on** during which event the street is liable to be obstructed.

**AND WHEREAS** the said Stroud District Council is empowered by Section 21 of the Town Police Clauses Act 1847, as amended, to make an Order prohibiting the use of that street by all classes of vehicles.

**NOW THEREFORE** in exercise of the powers conferred by Section 21 of the Town Police Clauses Act 1847, as amended, the Stroud District Council **DOES HEREBY ORDER** that all classes of vehicles in the street listed in the Schedule hereto other than those vehicles employed by any emergency service shall be prohibited.
